Subject: JAPAN 24 Hours Advance Filing Rules - Testing start

Dear valued clients,

Japan Advance Manifest Filling Rules (JP 24) will come into force in March,2014. Starting from the vessel ETA Japan port 10th, March, complete Shipping Instruction must be submitted and confirmed within the deadline at the Port of Loading, otherwise the container can not be discharged at Japan ports.

From the beginning of Feb,2014, SITC will implement the new regulation for the shipment to Japan. SITC will set the deadline for complete Manifest submission & BILL Confirmation of each routing as below. We will leave the buffer time for waiting B/L Confirmation and Japan Custom approval in system.

According to Japan Custom and Tariff Bureau, Manifest submission will be rejected in Custom system of NACCS if HS code dose not belong to the data set in Custom website. We kindly request you to remark the correct HS code in Shipping Instruction at the first time when you submit to SITC to avoid the unnecessary delay.

NVOCC (Non Vessel Operating Common Carriers) also need to submit the Manifest of House Bill as per the requirement of Japan Custom. Please be advised that SCAC (Standard Alpha Carrier Code) in NACCS of SITC Container Line is 12PD.
